1. All tickets, vouchers and other documents relating to transport, accommodations or other services and facilities (hereinafter referred to as "the travel services") are issued by or on behalf of Morro Negrillo S.A. (hereinafter referred to as "the company") only as agents for each of the concerns with whom the company may have arrangements for its clients (hereinafter referred to as "the principals") and are issued subject to these terms and conditions and those of the

company). Failure by the client to pay the said deposit by the due date will entitle the company to cancel all bookings made.

4. Any cancellation made by a client must be approved in writing. The following cancellation fees will be charged:

The company shall not be liable in the event, due to climatic conditions, that satisfactory surf is unavailable or that surf is of too great a magnitude for a client to participate in such activities. The passengers shall comply with instructions of the principals at all times. No passengers shall remain on a tour while their status or physical condition is, in the opinion of the principals, such as to render them incapable of caring for themselves and nor shall any passenger make themselves liable to other passengers or become a hazard to yes or other passengers and the company will be responsible for expenses by such persons upon completing the tour for these reasons.
